Since writing you yesterday, we find where our Mr. Myers was called out of the city before getting in touch with you, and as he may possibly be away for a week or ten days, we are taking the matter up further with you by correspondence.

We wish to advise that we have two good weavers, who have had considerable experience on secret work, that we would like to offer you for immediate employment on a yearly basis.

Our rate for each of these parties would be. \$6.00 per day and any small incidental expense which they may spend in knocking around with your employees while off duty; however, a limit could be put on money spent in this manner, say from \$5.00 to \$10.00 per month. There would be no charge for living expense.

For a period of from one to six months, the rate would be \$6.00 per day and transportation from Philadelphia to Atlanta and return. For any time less than thirty days, the rate would be \$7.00 per day, time enroute both ways, and transportation from Philadelphia to Atlanta and return.

For reference in your State you could write Mr. L. A. Thomas, President of The John P. King Manufacturing Company at Augusta, and Mr. T. S. Raworth, President of The Sibley Manufacturing Company of Augusta. For local reference we can refer you to Mr. Chas. A. Wickersham, Pres. & Gen. Mgr. of the Atlanta & West Point R.R.

We think very highly of the two operatives we have in view, and they can be absolutely depended on to give unbiased reports. If for any reason you have any troubles going on at the present time, which need immediate attention, and will send us telegram, stating "Can use one or both pieces of material" we would understand and make arrangements to send the same forward


